# **HOW TO ENTER**

The Contest begins on September 1, 2021 at 10:00 AM/PM??? and ends with all entries submitted online by 11:59 PM (MT) on September 19, 2021 (hereinafter referred to as the "Contest Period").

The participants must nominate a neighbour in the same neighbourhood as they reside and must not live in the same household.

Prize winners will be contacted by 5:00 PM (MT) on Monday September 20, 2021.

# **PRIZE**

There are two prizes available to be won, each consisting of:

The prize will be randomly awarded to one eligible Contest entrant. The prize must be accepted as awarded. The prize is not redeemable for cash or credit, in whole or in part.
