Presentation from Chamber of Commerce on Villeneuve Airport

The Committee received a presentation from Lynda Moffat of the St. Albert Chamber of Commerce about the Chamber's history in relation to, and their position on the growth and development of, Villeneuve Airport.

The presentation consisted of the history between the Chamber and EIA. Primary areas of advocacy include having the airport named as an alternate for media-vac services, collaboration toward improving services such as customs, aeronautical wildfire services, and flight school. Challenges such as Parkland Airport potentially facilitating scheduled air service, impacts of Villeneuve road closure, and lack of St. Albert representation on the EIA Board.
