1.0 PROJECT BACKGROUND

In 2014, the City of St. Albert contracted Banister Research & Consulting Inc. to conduct the 2014 Resident Satisfaction Research. As part of the research, Banister Research conducted 400 telephone interviews with members of the general population who resided within the city limits of St. Albert.¹

Age and gender quotas were established, as follows, to ensure proper demographic representation of St. Albert's residents:²

Overall results reflect a margin of error no greater than ±4.9% at the 95% confidence level, or 19 times out of 20.

In 2014, Banister Research was asked to conduct a seniors-specific analysis regarding perceived quality of life of those aged 65 or older (n=106) in the City of St. Albert. The following sections highlight the results from the 2014 General Population Telephone Survey, including comparisons to previous years' data (2007, 2008, 2009, 2010, and 2012), where applicable.³

2.0 SENIORS' PERCEIVED QUALITY OF LIFE

Sections 2.1, 2.2, and 2.3 detail the responses of those who self-identified as seniors, or being at least 65 years of age, on three (3) survey questions regarding perceived quality of life in St. Albert:

- How would you rate the overall quality of life in the City of St. Albert today?
- In your opinion, what would you say are the top factors contributing to a high quality of life in the City of St. Albert?
- What would you say are the top factors detracting from a high quality of life in the City of St. Albert, if any?

The overall results from the General Population Telephone Survey (n=400), and the Web-Based Stakeholder Survey (n=448) have been provided under separate covers.

³ The Resident Satisfaction Survey was not conducted in 2011 or 2013. As the Web-Based Stakeholder Survey was new to 2014, those results are also excluded from this report.

¹ 4,000 randomly selected households were also invited to complete a web-based version of the survey; 448 residents completed this version of the survey, the results of which are available under a separate cover.



2.1 Overall Quality of Life in St. Albert

All respondents were asked how they would rate the overall quality of life in the City of St. Albert, using a scale of "very poor," "poor," "good," or "very good." As shown in Figure 1, below, two-thirds (67%) of the seniors surveyed in 2014 (n=106) reported that the overall quality of life was "very good," an increase from 60% of seniors in 2012 (n=268). Just under one-third of seniors (29%) reported that the quality of life was "good" in 2014 (compared to 39% in 2012).

Overall, the vast majority of seniors in 2014 rated the quality of life as positive (96% rated it as either "good" or "very good" – a slight decrease from 99% of the seniors in 2013, and 98% of all respondents in 2014 (see Figure 2, on the following page).

Please Note: A different scale was used in prior to 2012, therefore results are not comparable to those in 2007, 2008, 2009, or 2010.⁴



2.2 Factors Contributing to a High Quality of Life

Next, respondents were asked what they considered to be the top factors *contributing to a high quality of life* in St. Albert. Thirty-six percent (36%) of the seniors surveyed in 2014 (n=106) mentioned the **parkland, green spaces, river, or trail system**, compared to 40% of all respondents in 2014 (n=400), and similar to 37% of seniors in 2012 (n=268).

Twenty-one percent (21%) of seniors in 2014 referenced the availability of community services and public facilities, a slight decrease from 24% of all respondents in 2014, but closer to 20% of seniors as reported in 2012.

Twenty percent (20%) of seniors in 2014 mentioned a **residential community atmosphere or "small town feel"** – consistent with both the overall sample in 2014, and the seniors surveyed in 2012.

Other responses that were **noticeably higher amongst seniors** (versus all respondents in 2014) included the following:

- Beautiful city and landscaping 16% of seniors compared to 13% of all respondents;
- Good road and sidewalk maintenance and/or snow removal 12% of seniors compared to 9% of all respondents; and
- Arts and cultural opportunities or historical features of St. Albert 8% of seniors compared to 5% of all respondents.

Conversely, responses that were **noticeably higher amongst all respondents** (versus the seniors surveyed in 2014), included:

- St. Albert is a safe place to live and/or has a low crime rate/good police presence 22% of all respondents compared to 11% of seniors (however, it should be noted that this particular response was mentioned by 17% to 19% of seniors from 2008 to 2012, suggesting an increasing sense of security amongst the elderly);
- Schools and educational opportunities 12% of all respondents compared to 7% of seniors;
- Clean and well-maintained city 12% of all respondents compared to 9% of seniors; and
- Availability of recreational services and programs 11% of all respondents compare to 8% of seniors.

Overall, the top three (3) responses provided by seniors in 2014 matched three (3) out of the top four (4) responses provided by all respondents, and were consistent, overall, with responses provided from 2007 to 2012. Top responses amongst seniors in previous survey years also included available shopping, amenities, and entertainment (21% to 27% from 2008 to 2012), which was mentioned by fewer than one-fifth of seniors in 2014 (18%).

2.3 Factors Detracting From a High Quality of Life

When asked about the factors that *detract from a high quality of life* in St. Albert, one-third (33%) of the seniors surveyed in 2014 (n=106) mentioned **high taxes or tax increases**, a decrease from 37% of all respondents in 2014 (n=400), and 35% of seniors in 2012 (n=268).

Sixteen percent (16%) of seniors in 2014 reported that there is **too much traffic in St. Albert and/or cited other traffic-related problems** (e.g., noise, speeding, etc.), a slight increase from 14% of all respondents in 2014, and a significant increase from 7% of seniors in 2012, suggesting that traffic congestion is a growing concern amongst seniors in St. Albert.

It is important to note that two (2) of the top responses from previous survey years were mentioned less frequently in 2014, both in terms of the overall response rate, as well as amongst seniors:

- Dissatisfaction with City Council (i.e., poor management/not accountable/lacking direction)
 - o 10% of seniors in 2012, but 8% of seniors in 2014 (5% of all respondents in 2014)
- Crime, including vandalism and problems associated with drugs and/or alcohol
 - o 12% of seniors in 2012, but only 4% of seniors and 4% of all respondents in 2014.
 - 2014 marks the first year that this response garnered a single-digit response rate among seniors (i.e., fewer than 10% of respondents).

Please Note: Prior to 2014, the question was phrased differently: "In your opinion, what would you say are the three (3) most significant factors contributing to a low quality of life in the City of St. Albert?"
