

Contest Rules

City of St. Albert – Servus Credit Union Place 15th Anniversary Contest (the “Contest”)

This Contest is intended for residents of Alberta only and will be interpreted according to the laws of Alberta. This Contest is being conducted by the City of St. Albert (the “Sponsor”).

NO PURCHASE NECESSARY TO ENTER OR WIN.

HOW TO ENTER

The Contest begins on or about 6:00 AM (MT) September 1, 2021 and ends by 11:59 PM (MT) on December 15, 2021 (hereinafter referred to as the “Contest Period”).

You are automatically entered if you are an annual Servus Place member. If you do not have an annual membership, mail in your name, address, email and phone number to Servus Credit Union Place 15th Anniversary Contest, #100, 110 Carleton Drive, St. Albert AB T8N 3Y4. Entries must be received within the Contest Period.

Prize winners will be contacted by 5:00 PM (MT) on Wednesday, December 22, five business days after the contest period ends.

PRIZES

Prizes will be randomly awarded to eligible Contest entrants. Prizes must be accepted as awarded. Prizes are not redeemable for cash or credit, in whole or in part. Some restrictions apply. No substitution or transfer of prizes is allowed except as noted in the contest prize and at the discretion of Contest Sponsor. In order to receive their prize, Contest winners must correctly complete a mathematical skill-testing question and sign a standard declaration and release form confirming compliance with the Contest rules together with a consent for the City of St. Albert to use the winner's name and likeness online, in print, and in any other media in connection with the Contest and for advertising and promotional purposes without further notice or additional compensation. Prize winners agree to cooperate with the Sponsor in arranging for photographs or other forms of publicity and to be available for photographs or other forms of publicity on reasonable notice.

THE DRAW

The prize draws will be conducted by the Sponsor no later than Monday, December 20, 2021 at 5:00 PM (MT) in St. Albert, Alberta. Selected winners will be notified by phone number or email. They will be contacted by 5:00 PM (MT) on Wednesday, December 22, five business days after the contest period ends.

One submission will be selected at random per draw.

Return of any prize notification as undeliverable or failure of the prize winner to successfully answer the skill-testing question within ten working days of notification of selection may result in disqualification and selection of an alternate winner.

Contest winners are responsible for picking up the prizes during normal weekday business hours within ten working days of successfully answering the skill-testing question. Noncompliance within this time period may result in disqualification and selection of an alternate winner(s).

ODDS

The chances of winning are dependent on the total number of eligible memberships and entries received during the Contest Period.

ELIGIBILITY

This contest is open to individuals who are residents of Alberta, have a Servus Place annual membership (adult, senior or family), and are 18 years of age or older by midnight on the last day of the Contest Period.

This contest is not open to employees or the Mayor and Councillors of the City of St. Albert.

GENERAL

This Contest is subject to all applicable federal, provincial and municipal laws and regulations. By entering the Contest, participants agree to be bound by these official Contest rules and the terms and conditions under which the prizes are awarded.

If, for any reason, this Contest is not capable of being completed as planned by the Sponsor including, but not limited to, computer virus, bugs, tampering, technical failures or other causes beyond the control of the Sponsor, the Sponsor reserves the right, in its sole discretion, to cancel or suspend this Contest or modify the Contest rules at any time. Further, the Sponsor generally reserves the right not to award a prize. The Sponsor may make substitutions of equivalent kind or value in the event of the unavailability of a prize (or component thereof) for any reason whatsoever. The Sponsor may terminate or withdraw this Contest at any time by posting a notice online. If the Contest is terminated on any day prior to the last day of the Contest Period (the "Termination Date"), the Sponsor may determine the winners from all eligible entries received as of 5:00 PM (MT) on the Termination Date (which winners shall be randomly selected in accordance with these Contest rules).

Any questions, comments or complaints regarding the Contest must be directed to the Contest Sponsor.

USE OF PERSONAL INFORMATION

By entering the Contest and voluntarily providing their personal information, including photos and videos of themselves as well as their dependents, all participants agree to the collection, use and disclosure by the Sponsor, and its respective employees and/or authorized agents, of participants' personal information for the purpose of administering the Contest, including, but not limited to, contacting selected winners. By entering the Contest, all participants agree to the use of their photos, videos, name, and likeness by the Sponsor online, in print, and in any other media in connection with the Contest and for marketing and promotional purposes. Personally-identifiable information will only be used to administer the Contest and for no other purpose, except as specifically outlined in these Contest rules. Personally-identifiable information will not be sold, shared or disclosed by the Sponsor or a third party engaged by the Sponsor for the purpose of administering the Contest. Participants' personal information is being collected under the authority of section 33(c) of the Freedom of Information and Protection of Privacy Act, R.S.A. 2000, c. F-25. In the event that, due to a printing, manufacturing, mechanical or other error of any kind or nature whatsoever, more prizes are claimed than are intended to be awarded according to these Contest rules, prizes will stop being awarded when the Sponsor becomes aware of an error respecting the number of prizes and the Sponsor reserves the right, in their sole and absolute discretion, to conduct a random draw from amongst all eligible and approved prize claimants whose claims have not yet been redeemed to award the remaining number of advertised prizes. In no event will the Sponsor be liable for more than the stated number of prizes contained in these Contest rules.

JURISDICTION

The Contest is governed by the laws of Alberta and the laws of Canada applicable therein, and is subject to all applicable federal, provincial and municipal laws and regulations and is void where prohibited by law. Participation constitutes your full and unconditional agreement to these Contest rules and the decisions of the Sponsor, which are final and binding in all matters related to the Contest. By entering the Contest, you agree that the courts of Alberta, Canada shall have jurisdiction to entertain any action or other legal proceedings based on any provision of this Contest's Rules or the running of this Contest.
