
The City of St. Albert offers funding support programs to assist with community events, and/or to help offset the cost of community capital projects.

BYLAW 6/2023 BEING AMENDMENT 12 TO OFFSITE LEVY BYLAW 30/2013

TAKE NOTICE that in accordance with Section 648 of the Municipal Government Act notice is hereby given of the intent of the Municipal Council of the City of St. Albert to consider an amendment to Bylaw 30/2013 a Bylaw to establish Offsite Levies for Sanitary Sewer, Storm Sewer, Water and Roadways.

Bylaw 6/2023, being Amendment 12 to Off-Site Levy Bylaw 30/2013 will be presented to Council on **March 21**, **2023**. The purpose of this Bylaw is to update content of the Bylaw, development area within the benefiting areas, the project list and the rates within the Bylaw.
